- applicants applying for active membership after June 30 pay one-half the SVMA fees for the respective category; this does not apply to educational, sabbatical, and social memberships
- Canadian veterinary college and AVMA-CoE accredited veterinary college grads:
 - complimentary membership for 2020 grads
 - 2017 grads can apply for a 25% reduction of CVMA fees if a CVMA member in 2018 & 2019
 - 2018 grads can apply for a 50% reduction of CVMA fees if a CVMA member in 2019
 - 2019 grads will automatically be invoiced a 75% reduction (\$79.75 plus gst) of CVMA fees
- educational members (residents and interns) and life practicing members pay 50% of CVMA fees
- CVMA membership due reductions if eligible are available for maternity/parental and illness disability leave – you must apply directly to the CVMA
- CVMA fees are optional for life non-practising, sabbatical and social members
- applicants applying for active membership between July 1st and November 1st pay the CVMA half-year rate (159.50 plus gst)
- all fees are subject to GST
- in general, all fees are non-refundable. However, requests for a refund will be considered under extenuating circumstances
- accounts more than 30 days overdue will be charged 2% per month, compounded monthly, from the date of the invoice
- membership fees will increase ~3% annual to match the annual rate of inflation
